

**FULL OFFICIAL RULES FOR
AAPCO 50th Anniversary Sweepstakes
Sponsored by AAPCO, LC**

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN TO ELIGIBLE RESIDENTS OF THE STATES OF VIRGINIA AND NORTH CAROLINA WHO ARE AT LEAST 18 YEARS OF AGE AND RESIDING IN THE ELIGIBLE GEOGRAPHIC AREA. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. INTERNET ACCESS REQUIRED.

- 1. Promotional Period:** The AAPCO 50th Anniversary Sweepstakes (the “Promotion”) runs from August 1st, 2018 at 12:00:00AM EST and ends December 31st, 2019 at 11:59:59PM. These are the Official Rules. All Promotion entries must be received prior to the end time and date specified above. Entries submitted past the expiration will not be accepted and will be destroyed. The Promotion consists of a single Grand Prize Sweepstakes (the “Sweepstakes”). The Grand Prize Sweepstakes will be awarded at the conclusion of the Promotion Period. A promotional day (“day”) as defined in these official rules is from 12:00:01AM EST to 11:59:59PM EST.
- 2. Administrator/Sponsor:** The Promotion shall be administered by AAPCO, LC (“Administrator”) and the sponsor is AAPCO LC, 6710 Jefferson Davis Highway, Richmond, VA 23237 (“Sponsor”).
- 3. Eligibility:** The Promotion is open only to legal residents in the states of Virginia and North Carolina, who currently reside in a zip code where AAPCO, BathPlanet of Richmond or SolarTyme provide service and who are at least the age of 18 at the time of entry. Void outside of Virginia and North Carolina and where prohibited. Potential participants may check the eligibility of their zip code/postal code by visiting aapcohi.com, and inputting their zip code into the respective field. Employees (and their immediate families (i.e., parents, spouse, children, siblings, grandparents, step parents, step children and step siblings and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of AAPCO, BathPlanet, SolarTyme, Best Value Remodelers and Sponsor, and each of their respective parents, affiliated companies, sponsors, subsidiaries, advertising and promotion agencies and third party fulfillment or judging agencies (collectively, the “Promotion Entities”) are not eligible to enter or win the Promotion.
- 4. How to Enter:** During the Promotion Period, complete the entry form available at a participating AAPCO, BathPlanet of Richmond, SolarTyme and Best Value Remodelers trade show and place completed entry in the on-site entry box (for Sweepstakes Entry only) or visit aapcohi.com and follow the links and instructions to navigate to the sweeps page of the site, and complete the required registrations fields.
 - A. Sweepstakes Entry:** Complete and submit the registration including a valid home address. P.O. Boxes are not permitted. Follow the on-screen instructions provided to: (a) register with Sponsor by completing all required fields contained on the Website (“Registration”); and (b) electronically agree to accept these Official Rules (“Rules”) (collectively, “Online Entry”). You automatically will receive one (1) entry into the Sweepstakes. Limit: Each participant may enter one (1) time. Only one entry allowed per email address. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities,

registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winner may be required to show proof of being the authorized account holder. Non-winning entries will be destroyed.

5. Grand Prize: Exactly one (1) \$5,000 Grand Prize will be awarded. One (1) Grand Prize Winner ("Grand Prize Winner") will be randomly drawn from among all eligible entries received during the Promotion Period. Grand Prize winner will be selected by random drawing from among all eligible entries received.

Grand Prize includes one (1) voucher usable for AAPCO, BathPlanet of Richmond, SolarTyme or Best Value Remodelers products and accompanying installation awarded in the form of a Gift Certificate (terms and conditions apply). Approximate Retail Value: \$5,000. Prize is non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. The number of eligible entries received during the Promotion Period will determine the odds of winning a Grand Prize. Sponsor reserves the right to substitute the prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winner is responsible for all taxes and fees associated with prize receipt and/or use of the prize. In the event the Grand Prize winner has already purchased a home improvement product during the Promotion Period, the winner would receive the option to have the \$5,000 applied towards any balance due on that project or use the \$5,000 towards a new project with AAPCO, BathPlanet of Richmond, SolarTyme or Best Value Remodelers.

Total ARV of the Grand Prize to be awarded in this Promotion is \$5,000.

6. Notification: Administrator is AAPCO, LC whose decisions as to the administration and operation of the Promotion and the selection of the potential winner are final and binding in all matters related to the Promotion. The potential winner will be notified by mail, email or phone. Upon receiving the Winner notification response, Administrator may send each potential Winner an Affidavit of Eligibility and Publicity (where legal) and Liability Release, which will need to be completed, signed and returned to Administrator within seven (7) days of receipt of the Release. If any Prize notification or attempted notification is returned as undeliverable, that Prize may be forfeited and awarded to an alternate Winner, time permitting. Administrator and Sponsor are not responsible for lost, late, damaged, delayed, or illegible paperwork. By signing the Release, the winner acknowledges compliance with these Official Rules. Odds of winning a Prize depend upon the number of eligible entries received. Potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. In the event that a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held after which the prize will remain un-awarded. Prize will be fulfilled approximately 8-10 weeks after the conclusion of the drawing.

7. Release: By receipt of any prize, winner agrees to release and hold harmless Sponsor, Administrator, and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion

agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Promotion or receipt or use or misuse of any prize.

8. Publicity: Except where prohibited, participation in the Promotion constitutes winner's consent to Sponsor's and its agents' use of winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration.

9. General Conditions: Sponsor reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Promotion, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

10. Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Promotion, during the applicable Promotion Period. If the Sponsor discontinues the Promotion for any reason, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. No more than the stated number of prizes will be awarded. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth in these Official Rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.

11. Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Virginia (Southern Division) or the appropriate Virginia State Court located in Richmond, Virginia; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other

than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the State of Virginia without giving effect to any choice of law or conflict of law rules (whether of the State of Virginia or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Virginia.

12. Entrant's Personal Information: All personal information that Entrants submit will be subject to Sponsor's privacy policy.
